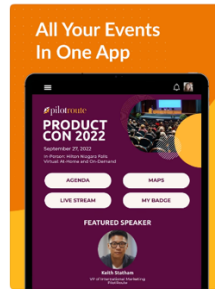
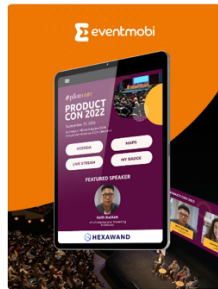

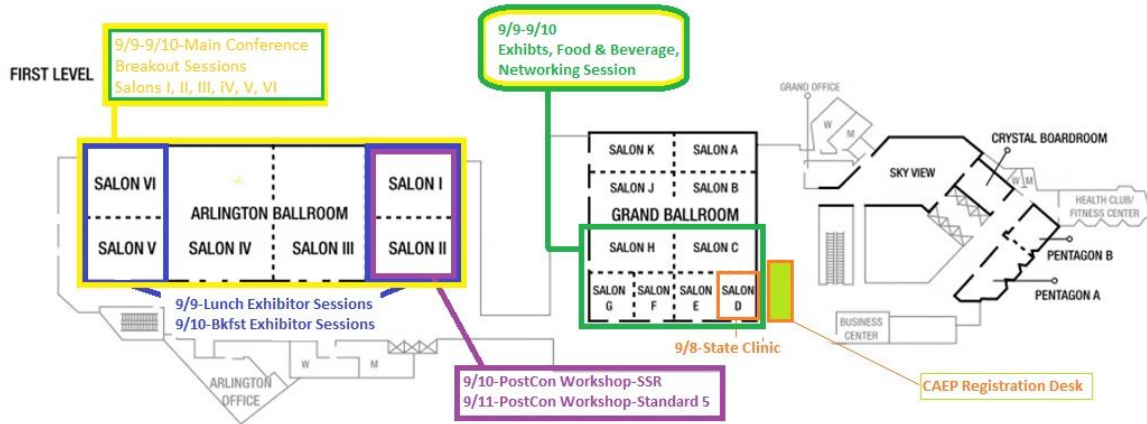

### *Evaluating and Improving Teacher Preparation Programs: Consensus Recommendations*

The NAEd's mission is to "advance high-quality research to improve education policy and practice." This NAEd consensus report provides research-informed recommendations for TPP self-study and evaluation, as well as contextualizes the

critical work of TPPs in the larger societal context and provides policy recommendations for key stakeholders. For this CAEP session, we will describe the research basis of the report and the recommendations. The report describes the various evaluative entities – including the roles of state governments, national professional accreditation organizations, regional accrediting agencies, TPPs themselves, the federal government, and media outlets – shaping the field of TPP evaluation, which bring about multiple evaluation objectives and processes that present both challenges of data collection burden and opportunities for program improvement. Grounded in the scientific research on the knowledge, skills, and dispositions that teachers need to support student learning and development, the report identifies crucial TPP features associated with high quality preparation as targets for evaluation and provides a roadmap that links key evidence and measures to these TPP features while also addressing the strengths and weaknesses of these measures. The report also highlights teacher preparation systems in other high achieving countries as examples of effective evaluation processes.

This research informs the final chapter which provides 20 research-informed consensus recommendations to support TPP evaluation and improvement in the following areas: (1) TPP approval and accreditation; (2) TPP self-study; (3) system supports for TPP evaluation; and (4) system supports for teaching and teacher preparation.

## ***A CBE Program's Self-Study Report: A Road Map for Success***

The design and delivery of a Competency-Based Education (CBE) program significantly impacts both student learning outcomes and accreditation standards such as those set by CAEP. This year, Pathway to Practice NC has actively participated in the CAEP accreditation process, submitting its SSR in August 2024.

In this presentation, we will explore our delivery methods as self-paced learning, personalized instruction, and competency-based assessments and how these elements can be used in the accreditation process. We will also address how the curriculum design principles tailored to CBE frameworks, including competency mapping, alignment with standards, and the integration of authentic assessment methods, were utilized as we wrote the Self-Study Report.

The presentation will address both challenges and opportunities of the CBE delivery and design elements, such as defining and operationalizing cycles of data, identifying relevant data points, establishing assessment intervals, and leveraging data to inform instructional decision-making. We'll examine the alignment of key assessments to standards and the implementation of rubrics for consistent and objective evaluation. We will also discuss techniques for maintaining data integrity, mitigating bias, and utilizing data-driven insights to enhance program effectiveness.

### ***Empowering Small EPPs for Success: Navigating Challenges Through Strategic Partnerships, Collaboration, and Resource Allocation***

Research on challenges encountered by smaller Educational Preparation Programs (EPPs) underscores common themes and issues. Limited resources, including funding, personnel, and infrastructure, pose significant obstacles to meeting accreditation standards and delivering high-quality teacher education (Campbell & Grossman, 2013). Additionally, faculty members in smaller EPPs often juggle multiple roles, such as teaching, advising, research, and administration, which can impede their ability to allocate sufficient time and attention to accreditation-related tasks (Cochran-Smith et al., 2015). Moreover, smaller EPPs may struggle with accreditation and accountability processes due to a lack of institutional support and resources for data collection, analysis, and improvement efforts (Bullough et al., 2016). Establishing and sustaining partnerships with local schools, districts, and community stakeholders is critical for small EPPs to provide quality teacher

education and support candidate success, yet these efforts often face challenges in resource allocation and sustainability (Henrickson, 2016).

Addressing the challenges encountered by smaller Educational Preparation Programs (EPPs) demands a multifaceted approach centered on strategic partnerships, collaboration, and resource optimization. By fostering productive stakeholder engagement, cultivating strategic partnerships with ongoing support from university administration, policymakers, and other stakeholders, and maximizing internal and external resources, small EPPs can enhance program effectiveness and sustainability (Campbell & Grossman, 2013; Cochran-Smith et al., 2015). These strategies are instrumental in assisting smaller EPPs in navigating the challenges associated with Standard 6: Fiscal and Administrative Capacity, ensuring compliance with all accreditation standards, particularly Standards 2 (R2.1, R2.2, and R2.3), 3 (R3.1), and 5 (R5.3 and R5.4), and fulfilling their educational mission. This session is designed to facilitate dialogue among small EPPs, providing a platform to share strategies and insights, fostering collective learning and collaboration to overcome challenges and thrive despite constraints. This session centers on three critical elements essential for small Educational Preparation Programs (EPPs): partnership, collaboration, and resource allocation. Participants will explore strategies to cultivate strategic partnerships with schools, districts, and university departments, leveraging combined resources and expertise to enhance program effectiveness and sustainability. Through interactive discussions, attendees will learn how to foster a culture of collaboration within their programs, empowering stakeholders to work together towards common goals and fostering a sense of collective ownership. Additionally, the session will delve into approaches to optimize resource allocation, including fiscal, personnel, and infrastructure, by identifying priority areas and leveraging available resources efficiently through effective collaboration and communication. Missouri Western State University is an open-enrollment institution serving a significant population of students that are first generation college students and Pell Grant recipients in a largely rural, but increasingly diverse region of Northwest Missouri. Many potential teacher candidates enter the university with gaps in academic preparation and support systems. In an effort to remove barriers to individuals interested in entering the teaching profession, particularly those from underrepresented backgrounds, the EPP aims to admit all students with the potential to become excellent teachers. This approach occasionally results in candidates who demonstrate dispositional concerns and require supportive intervention. As such, the EPP has developed a robust system, and concurring policies, for reporting, monitoring, and addressing dispositional concerns. This presentation will share the aims, policies, processes, tools, and outcomes surrounding the EPP's Teacher Education Admission and Retention Committee

(TEARC). These systems were cited as a model by the EPP’s CAEP Site Review Committee and were instrumental to the EPP’s positive accreditation outcome, particularly for monitoring and supporting candidate progression (CAEP Standard R3.2).

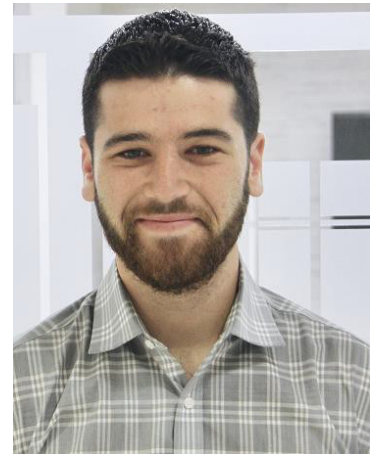
